AUDIT EXECUTIVE SUMMARY:

A review of activities at Pier C Ranch in Leamington, near Point Pelee was completed. Mechanical harvesting of carrots was observed from field 4-5C. 3 members of the harvest crew were observed on the day of the audit. Harvest machine dedicated for carrots with a conveyor to pick carrtos from ground then passed through conveyor to remove leaves. Carrots are then transferred to wooden bins to be taken to the transfer station. Product is transported in enclosed trailers from the transfer station to either Leamington packhouse or Chatham Processing facility for further grading and packing. There are a total of 9 employees (5 at transfer station and 4 at mechanical harvest) with 194 acres for carrots, 160 acres for onions, and 39.5 acres for beets. Product is sold in the US and Canada. Canal water (Lake Erie) is used for overhead irrigation and municipal water is used at the transfer station for chemical mixing and sanitation in washrooms. There is a portable toilet with a hand wash sink for the ranch. Pier C Farm has always been used for agriculture per assessment. Pesticides and fertilizers purchased from approved supplier and applied by licensed individuals at the facility. Field numbers are used to identify growing locations. Season is July through October.
