AUDIT EXECUTIVE SUMMARY:

Pier C, Leamington site cleaning, grading, packing, storing and distributing conventional Onions to Canada and USA from their farm or approved suppliers. The operation is located in the heart of Leamington. The product is transported to the line according to the customer' orders. The wood bins stored from the farm are transported by forklift and then dumped into the line. The product dumped is inspected in a conveyor to eliminate bad quality products, then onions are transported through an inclined conveyor until an Onion Topper and brusher, then grade and sizer. The product can be bagged in different presentations 50lb, 3 lbs, 2 lbs and 10 lbs. A mobile inclined finger conveyor is used for 50lbs bags, the smallest quantities are send to a fixed inclined conveyor where the product goes to automatics weighers and then packed and labelled. The product is again inspected in a carrousel bagger by the employees and palletized according to the customer's requirements. Thirteen employees were working during the audit day.
